DATE OF MEETING	13 July 2020
OUTCOME	No Grounds to Proceed

Advertisement: The television advertisement for the advocacy group, 50 Shades of Green shows images of a food producing sheep farm. The advertisement says “Farmers aren’t anti-trees, sheep and beef farms are covered in native vegetation.” The advertisement compares food farming to carbon farming and ends with the Advertiser’s name, 50 Shades of Green, and the message “Save Farms for Food.”

The Chair ruled there were no grounds for the complaint to proceed.

Complaint: The advertisement is loaded and carries plenty of misinformation, saying land should be used for the meat industry rather than carbon credits and forestry. Should be pulled from television.

The relevant provisions were Advertising Standards Code - Principle 2, Rule 2(b), Rule 2(e);

Principle 2: Truthful Presentation: Advertisements must be truthful, balanced and not misleading.

Rule 2(b) Truthful Presentation: Advertisements must not mislead or be likely to mislead, deceive or confuse consumers, abuse their trust or exploit their lack of knowledge. This includes by implication, inaccuracy, ambiguity, exaggeration, unrealistic claim, omission, false representation or otherwise. Obvious hyperbole identifiable as such is not considered to be misleading.

Rule 2(e) Advocacy advertising: Advocacy advertising must clearly state the identity and position of the advertiser. Opinion in support of the advertiser's position must be clearly distinguishable from factual information. Factual information must be able to be substantiated.

The Chair noted the Complainant’s concern the advertisement is loaded and includes misinformation.

The Chair referred to the ASA Guidance Note on Advocacy Advertising, which includes the following definition of Advocacy Advertising: “Advocacy advertising is often characterised by parties having differing views that are expressed in robust terms. This is especially so when there is proposed legislation or a referendum on an issue. Examples include abortion, fluoridation, immunisation and legalisation of marijuana. Government advertising on a range of health and safety initiatives is also likely to be advocacy advertising.

The Chair noted the requirements of Rule 2(e) of the Advertising Standards Code. This Rule requires the identity and position of the advertiser to be clear; opinion to be distinguished from factual information and factual information must be able to be substantiated. The Advocacy Principles developed by the Complaints Board in previous decisions considered under Rule 11 of the Code of Ethics remain relevant. They state:

1. That section 14 of the Bill of Rights Act 1990, in granting the right of freedom of expression, allows advertisers to impart information and opinions but that in exercising that right what was factual information and what was opinion, should be clearly distinguishable.
2. That the right of freedom of expression as stated in section 14 is not absolute as there could be an infringement of other people's rights. Care should be taken to ensure that this does not occur.
3. That the Codes fetter the right granted by section 14 to ensure there is fair play between all parties on controversial issues. Therefore, in advocacy advertising and particularly on political matters the spirit of the Code is more important than technical breaches. People have the right to express their views and this right should not be unduly or unreasonably restricted by Rules.
4. That robust debate in a democratic society is to be encouraged by the media and advertiser and that the Codes should be interpreted liberally to ensure fair play by the contestants.
5. That it is essential in all advocacy advertisements that the identity of the advertiser is clear.

The Chair said the identity of the Advertiser was sufficiently clear as the organisation's name, 50 Shades of Green, was present for an appropriate portion of the advertisement and a search of the name on the Internet resulted in clear information as to the Advertiser's ethos of the right trees being planted in the right places for the right purposes. The Chair said the Advertiser's position was also made clear in the advertisement by the line "Save Farms for Food." The advertisement therefore met the criteria for an advocacy advertisement.

The Chair said the content in the advertisement represented the views of the advocacy group, 50 Shades of Green, who are concerned about the future of New Zealand's hill country farms and it was permitted under the rule for advocacy advertising. The Chair said the advertisement was clearly 50 Shades of Green's perspective on the need to balance the management of climate change and the preservation of farms.

The Chair acknowledged the Complainant's genuine concerns about the content of the advertisement, however this expression of opinion was permitted under the Advertising Standards Code.

The Chair noted the Complaints Board had considered several complaints about the forestry, farming and climate change debate including Decisions 19/294, 19/310 and 19/381 which were not upheld when considered within the context of advocacy advertising. The Chair said the advocacy advertisement did not meet the threshold to breach Principle 2 or Rule 2(b) and complied with the requirements of Rule 2(e) of the Advertising Standards Code.

The Chair ruled there were no grounds for the complaints to proceed.
